MODULE 4.4

DECISIVE POWER ABILITY

“The first requisite for success is the ability to apply your physical and mental energies to one problem incessantly without growing weary.”

THOMAS EDISON

Too many people are caught in the trap of thinking that only hard physical labor is real work. However, a person is not idle because he or she is absorbed in thought — on the contrary. As demonstrated by Leonardo da Vinci and Thomas Edison, the two greatest inventors ever, both physical *and* mental energies need to be applied on the journey to a successful result. The process of creation begins with thought and ends with action, so both are of immense importance in designing one’s life for maximum success.

There are two types of work that need to be aligned in harmony to produce optimal performance — *visible* labor and *invisible* labor:

- Visible labor – physical effort.
- Invisible labor – mental effort.

Visible labor is the work that people can see — it is physical in nature, such as a manager spending ten hours at the office or a factory laborer working at a machine all day. Whereas invisible labor cannot be seen — it occurs within the mind, such as inventing or authoring or brainstorming or the creation of ideas and notions and concepts. Most multi-millionaires spend more time doing invisible labor than they spend at physical work. This doesn’t mean they don’t work hard, because they do. It means they spend a considerable time focused on

thinking about what must be done to achieve the result with the optimal effort — this is also known as *working smart*. Most multi-millionaires have teams of people at their fingertips that can do the hard labor for them. Large incomes always begin in the mind of the successful person before manifesting via physical labor.

Recognizing My *Decisive Power Ability*

In my quest for success, I must focus on both types of work — *visible* and *invisible* labor. In this manner, I will be maximizing all my abilities — physical and mental. This brings me to my *Decisive Power Ability*. This is the major skill, under my mental control, which when performed with physical excellence, will empower me to reach the maximum success of which I am capable. Using James Lee Valentine as the example again, here is his *Decisive Power Ability* that empowers him to concentrate on the mental and physical strengths that can lead him to success as the creator of empowering success systems:

No Problem . . . I Seek The Solution

My *Decisive Power Ability* is primarily limited to the glamour arenas of business, career and financial, and it is of vital importance to me in those areas. As such, I should be aware that my ability to positively transform my words — transformational vocabulary — is also vital to the business, career or financial success I seek. In this respect, my choice of one word over another is so very important. For example, the word ‘problem’ is wrought with negativity and conjures up disempowering images for all involved. Even its sister words ‘predicament’ and ‘plight’ and ‘dilemma’ are heavy because they imply a pessimistic situation. The preferred alternative is to focus on the ‘solution’ which is far more intriguing and leads to a whole series of empowering choices.

When something is described as a ‘problem’ it is a dead-end in that it is a statement of disempowerment, not necessarily true either. It conjures images in the mind of sitting back and doing little except for worry. However, the word ‘solution’ connotes forward motion, focusing the mind on the answers to the problem. A football team cannot score when playing defense — they can only score when going forward. The same is true for me — I can only score a positive result when working toward a solution. Now, here is the key point in all this: No matter the language used — problem, difficulty, predicament, plight, dilemma, challenge — the desired positive result is the same. A *solution* is being sought to that which is causing distress. My belief is that substituting the words ‘I seek the solution’ instead of ‘I have a problem’ will focus my mind on a constructive resolution far more readily than otherwise.

An Entire Armada Of Power-Laden Solutions

What I need, as an Empowered Millionaire, are not just one or two ordinary solutions, I require an entire armada of power-laden extraordinary solutions that will provide me with answers to any challenge that I will ever face.

There are five steps involved in developing a wide variety of empowering *Power Solutions* to solve any problem:

1. Write the 'original problem' being faced as a concise, specific sentence. The problem needs to be out in the clear where it can be fully analyzed.
2. Brainstorm a 'multitude of solutions' for the problem. At this stage, think of as many solutions as possible, writing the ideas as they flow to my mind one after another, non-stop.
3. The 'best solutions' next need to be thoroughly scrutinized to find the ones that have greatest suitability for solving my exceptional situation.
